No.....Dated...../ In exercise of powers conferred under section 9 of the Bihar Probation of Offenders Rules, 1959 made under section 17 of the Probation of Offenders Act, 1958, the Governor of Bihar is pleased to make the following Rules for the amendment of the Bihar Probation Service Rules, 2014:-

**“Bihar Probation Service (Amendment) Rules, 2015”.**

1. **Short title, extent and commencement.** - (1) These Rules shall be called the “Bihar Probation Service (Amendment) Rules, 2015”.  
(2) It shall extend to the whole of the State of Bihar.  
(3) It shall come into force with immediate effect.
2. The words ‘**Deputy Director, Probation**’ shall be inserted after the words ‘**Principal Probation Officer**’ used in sub rule (1) of rule-3 of these Rules, 2014.
3. The following new clause (ii a) shall be inserted after the clause (ii) of sub rule (1) of rule-8 of these Rules, 2014 and the word ‘**second**’ in the clause (iii) shall be substituted by the word ‘**third**’:-

“(ii a) Deputy Director, Probation - Second Stage of Promotion.”
