महाशय,

निदेशानुसार उपर्युक्त विषयक गृह मंत्रालय, भारत सरकार के पत्रांक- 45020/14/2016-IPS- II दिनांक-09.01.2017 की छायाप्रति (अनुलग्नक सहित) संलग्न करते हुए कहना है कि भारतीय पुलिस सेवा के पदाधिकारियों के लिए पंचांग वर्ष 2016 की वार्षिक अचल सम्पत्ति विवरणी SPARROW System के तहत दिनांक-31.01.2017 तक ऑनलाईन समर्पित किया जाना अनिवार्य है।


उक्त के संबंध में यह भी सूचित करना है कि विभागीय पत्र संख्या-10158, दिनांक-27.12.2016 के द्वारा बिहार संवर्ग के भारतीय पुलिस सेवा के पदाधिकारियों को, वर्ष 2016 की वार्षिक अचल सम्पत्ति विवरणी SPARROW System के तहत ऑनलाईन समर्पित करने हेतु पूर्व में भी दिशा-निर्देश दिया गया है, किन्तु भारतीय पुलिस सेवा के कतिपय पदाधिकारियों द्वारा वर्ष 2016 की वार्षिक अचल सम्पत्ति विवरणी की हार्ड कॉपी विभाग तथा गृह मंत्रालय, भारत सरकार को उपलब्ध करायी जा रही है, जो स्वीकार्य नहीं है।

ज्ञात हो कि लोकपाल एवं लोकायुक्त अधिनियम, 2013 की धारा 44 के अन्तर्गत वार्षिक आस्तियों एवं दायित्वों की विवरणी भारतीय पुलिस सेवा के पदाधिकारियों द्वारा समर्पित किये जाने का प्रावधान सम्प्रति गृह मंत्रालय, भारत सरकार द्वारा शिथिल कर दिया गया है। अतएव इस आशय की विवरणी समर्पित करने का कोई औचित्य नहीं है।

अतः अनुरोध है कि वर्ष 2016 की वार्षिक अचल सम्पत्ति विवरणी SPARROW System के अन्तर्गत ऑनलाईन दिनांक 31.01.2017 तक अनिवार्य रूप से समर्पित करने की कृपा की जाय, अन्यथा निगरानी स्वच्छता बाधित रहेगी। साथ ही वार्षिक अचल सम्पत्ति विवरणी SPARROW System के अन्तर्गत ऑनलाईन समर्पित करने में किसी भी प्रकार की कठिनाई होने की स्थिति में supportsparrow@nic.in or sparrow.ips@nic.in से ई-मेल की माध्यम से मदद ली जा सकती है।

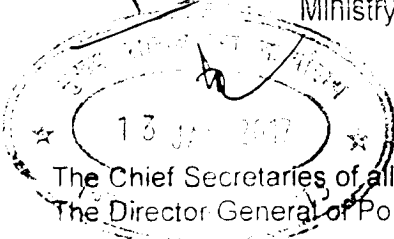

Sub: Online submission of Immovable Property Return by IPS officers through- Reg.

Sir,
I am directed to refer to this Ministry's letter of even number dated 13.12.2016 (copy enclosed) on the subject and to say that IPS officers are required to file the Immovable Property Return (IPR) for the year 2016 online through SPARROW. But some IPS officers are not following this Ministry's Instructions dated 13.12.2016 and they are submitting IPR for the year 2016 offline (hard copy). In this regard, it is requested that such officers may be directed to comply with the instructions dated 13.12.2016.

2. It is also noticed that some IPS officers have filed the annual returns of Assets and Liabilities under Section 44 of the Lokpal and Lokayuktas Act, 2013 online instead of Immovable Property return for the year 2016. As per this Ministry instructions dated 13.12.2016 conveyed vide letter no. 26012/01/2014-IPS.II (copy enclosed) at present there is no requirement for filing of annual returns of Assets and Liabilities under Section 44 of the Lokpal and Lokayuktas Act, 2013.

3. In view of the above, it is requested that the instructions dated 13.12.2016 may be widely circulated to all concerned officers for strict compliance in respect of filing of Immovable Property Returns under the provisions of the AIS (Conduct) Rule, 1968 through online within the prescribed time limit i.e upto 31.01.2017. In case of any difficulty in accessing IPR module through Sparrow the officer may send their grievances through e-mail at support-sparrow@nic.in or sparrow.ips@nic.in.

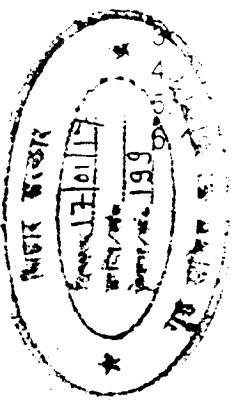


Please refer to this Ministry's letter of even number dated 9.8.2016 and DoPT letter dated 29.7.2016 regarding the furnishing of information relating to assets and liabilities by AIS officers under section 44 of the Lokpal and Lokayuktas Act, 2013.

2. DoPT vide their letter No. 407/16/2016-AVD-IV(LP) dated 1.12.2016 (copy enclosed) have conveyed that under the **Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rules, 2014 there is no requirement for filing of declarations of assets and liabilities by public servants now.** The Government is in the process of finalising a fresh set of rules. The said rules will be notified in due course to prescribe the form, manner and timelines for filing of declaration of assets and liabilities by the public servants under the revised provision of the said Act. All public servants will henceforth be required to file the declarations as may be prescribed by the fresh set of rules.

3. In view of the above, it is requested that these instructions may be widely circulated to all concerned.

Subject: Declaration of Assets and Liabilities by public servants under amended section 44 of the Lokpal and Lokayuktas Act, 2013 – reg.


The undersigned is directed to refer to this Department's OM of even number dated 29th July, 2016 (copy enclosed) regarding the furnishing of information relating to assets and liabilities by public servants under section 44 of the Lokpal and Lokayuktas Act, 2013 (the Act).

2. In this regard it is stated that with the passing of the Lokpal and Lokayuktas (Amendment) Act, 2016 (copy enclosed), the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rules, 2014 and all the amendments made thereto have become redundant.

3. The Lokpal and Lokayuktas (Amendment) Act, 2016, as referred to above, substitutes the provision of section 44 of the Principal Act by the following new provision:-

"44. On and from the date of commencement of this Act, every public servant shall make a declaration of his assets and liabilities in such form and manner as may be prescribed."

4. Thus, under the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rules, 2014 there is no requirement for filing of declarations of assets and liabilities by public servants now. The Government is in the process of finalising a fresh set of rules. The said rules will be notified in due course to prescribe the form, manner and timelines for filing of declaration of assets and liabilities by the public servants under the revised provision of the said Act. All public servants will henceforth be required to file the declarations as may be prescribed by the fresh set of rules.

Sub: Online submission of Immovable Property Return by IPS officers through- Reg.

Sir

In terms of Rule 16(2) of All (India) Services (Conduct) Rules, 1968, every member of the service shall submit his/her Immovable Property Return (IPR) in the prescribed form by 31st January of every year in respect of the previous year ending 31st December.

2. Now, it has been decided that IPS officers would file the Immovable Property Return through online. In this regard, an application, namely, IPR (Immovable Property Return) has been designed to enable the officer to file the return online. Since the application would be available in the SPARROW itself, no separate user ID and password would be required once the officer accesses SPARROW (<https://ips.gov.in> or <https://sparrow-ips.eoffice.gov.in>) by using his existing nic e-Mail ID and password.

3. After filing the above return online, the officer would have to authenticate it by using the Digital Signature Certificate (DSC) already issued to him under SPARROW. In this connection, a 'User Manual' to facilitate filing up the online Immovable Property Return (IPR) is also enclosed herewith and same is also available at welcome page of SPARROW.

4. It is further clarified that filing of Immovable property return under Rule 16 of the All India Services (Conduct) Rule, 1968 by all IPS officers is mandatory. The Immovable Property return for the year 2016 is required to be filed latest by 31st January 2017. In case the officer fails to submit the IPR (online) within the stipulated time limit his/her vigilance clearance will be denied in terms of DoPT OM No. 104/33/2005-AVD.I dated 7.9.2011.

5. As regards filing of returns of Assets and Liabilities under Section 41 of the Lokpal and Lokayuktas Act, 2013, it is stated that the DoPT dated 01.12.2016 have informed that there is no requirement for filing of such returns now. The Government is in the process of finalising a fresh set of rules. DoPT have further informed that the said rules will be notified in due course to prescribe the form, manner and timeliness for filing of declaration of Assets and Liabilities by the public servants under the revised provision of the said Act.

6. In view of the above, it is requested that these instructions may be widely circulated to all concerned officers for strict compliance in respect of filing of Immovable Property Returns under the provisions of the AIS (Conduct Rule, 1968 within the prescribed time limit through online. Henceforth Immovable Property Return in any other form will not be accepted. In case of any difficulty in accessing IPR module through Sparrow the officer could send their grievances through e-mail at support-sparrow@nic.in or sparrow.ips@nic.in.
